7. 평가 및 제언

- 한국의 여성에 대한 폭력 실태조사연구의 사례 발표를 통해 동남아 국가 뿐만 아니라 세계적으로 가장 체계화된 연구시스템을 갖춘것을 다시금 환기시키는 계기가 됨.
- 그러나 성인지 통계 데이터의 문제점과 한계는 여전히 있음을 파악
- 따라서 여성폭력에 관한 적절한 데이터 구축 및 사용을 위한 전략, 여성폭력지표의 지속적 작업, 여성폭력 근절을 위한 역량 증진에 대한 구체적 방안을 모색하여야 할 것임.
